





Notice of Application Received and Informational Meeting

In accordance with Sections 1-601, 1-602, and 1-603 of the Environment Article, Annotated Code of Maryland, the Maryland Department of the Environment (the "Department") is presently reviewing a Refuse Disposal Permit Application submitted by Tolson & Associates, LLC for the construction and operation of the proposed Tolson & Associates Rubble Landfill. This landfill, a nonhazardous solid waste acceptance facility, is proposed to be located at the end of Capital Raceway Road, Crofton, in Anne Arundel County, Maryland 21114.

Notice is given that the Department will hold an Informational Meeting regarding this application on July 15, 2004 at 7:00 p.m. in the Crofton Elementary School Cafeteria, 1405 Duke of Kent Drive, Crofton MD. The purpose of the Informational Meeting is to provide an opportunity to the general public to obtain information about the permit application and the Department's review process. Representatives for the applicant and the Department will be available to answer specific questions.

Upon prior request, an interpreter for the deaf or hearing-impaired persons will be provided. The application and supporting documents will be available for public review at the Anne Arundel County Public Library (Crofton Branch) located at 1657 Crofton Center, Crofton, Maryland; the Anne Arundel County Public Library, (Odenton Branch), 1270 Odenton Road, Odenton MD and at the Department by appointment after June 29, 2004.
